Gentlemen,

The MGNWC has enjoyed a cooperative relationship with the City of Evanston regarding the completion of the Intermediate Booster Pump Station at 2551 Church Street in Evanston. While MGNWC contracted for the demolition of the Shore School and managed the environmental cleanup work, to accommodate our pump station, Evanston reimbursed the MGNWC for demolition and engineering work related to the preparation of the site for construction. As you may recall the MGNWC was required to purchase, at over \$60,000, a one-year construction easement from the MWRD to construct the pump station itself which accommodated the building construction but little staging area for the work. That additional staging property was provided by the City of Evanston at no cost using the Evanston easement area to the North and East of the pump station but with a condition that the site controlled by Evanston would be restored by the MGNWC when construction was completed. We have reached that point that restoration including placement of pulverized soil, approved seed, seed blankets to stimulate growth, and watering should be undertaken between now and November 15 to assure growth. The prime contractor for the pump station, JJ Henderson is in the process currently of establishing his finished grade as a part of their contract, and the Evanston easement work will then match the work of JJ Henderson's work.

In order to meet the seasonal targets, I solicited quotes from two landscape contractors, Milieu Landscaping, Wheeling, IL and Staples and Son Landscaping, Lake Zurich, IL. While the MGNWC could have engaged JJ Henderson and Son through a change order, I believed this would not be the lowest cost to secure this additional work due to mark up costs and pricing we have seen with other change orders from this contractor. The quotes received were from reputable landscaping firms capable of completing this work by November 15, 2019. The quotes received were:

Staples and Son:	\$ 38,385.00
Milieu Landscaping:	\$ 61,550.00
Milieu Landscaping: alternate bid with less topsoil:	\$ 35,000.00
(Evanston requested 6" of topsoil)	

The MGNWC Purchasing manual Chapter two paragraph G permits bid waivers when in the interests of the Water Commission. It states:

"G. Waiver of Competitive Bidding

The Water Commission, by two thirds vote of all of the Commissioners then holding office, may waive the bidding procedures and enter into a contract of agreement. Requests for bid waivers shall be made only when goods or services are proprietary (i.e. sole source), where standardization is necessary or desirable, in emergencies as defined in this manual, **or when it is in the best interest of the Water Commission to do so.** In an instance, a statement justifying the need for a bid waiver shall be included in the recommendation".

To meet the seasonal requirements for establishing a lawn this fall and to match the site preparation work on the pump station site, I recommend that Staples and Son Landscaping and Excavating PO Box 31 Lake Zurich, IL 60047 be awarded the restoration landscaping work adjacent to 2551 Church, Evanston for a not to exceed amount of \$45,000 (to provide for additional watering if needed) as a qualified firm presenting the lowest cost to the Water Commission. I recommend bid waiver as being in the best interests of the Water Commission to do so.

RESOLUTION AUTHORIZING BID WAIVER CONTRACTUAL AGREEMENT WITH KD STAPLES AND SONS LANDSCAPING AND EXCAVATING OF LAKE ZURICH TO PROCEED WITH LANDSCAPING SERVICES EAST OF THE BOOSTER STATION LOCATED AT 2551 CHURCH STREET, EVANSTON IN AN AMOUNT NOT TO EXCEED \$45,000 FOR THE MORTON GROVE-NILES WATER COMMISSION

(MORTON GROVE-NILES WATER COMMISSION AND KD STAPLES AND SONS LANDSCAPING AND EXCAVATING)

WHEREAS, in 2017, the Morton Grove-Niles Water Commission ("MGNWC" or "Commission") was established by the Village of Morton Grove, a home rule Illinois municipal corporation ("Morton Grove"), and the President and Board of Trustees of the Village of Niles, a home rule Illinois municipal corporation ("Niles") by the adoption of ordinances pursuant to Division 135 of Article 11 of the Illinois Municipal Code (65 ILCS 5/11-135-1, *et seq.*) ("Division 135"). The establishing ordinances are Morton Grove Ordinance 17-5, which was adopted on March 13, 2017, and Niles Ordinance No. 2017-19, which was adopted on March 14, 2017. In order to accomplish the objectives set forth in the above-referenced Ordinances, Morton Grove and Niles also approved under those same Ordinances an intergovernmental agreement entitled, "Intergovernmental Agreement For The Establishment And Operation Of The Morton Grove-Niles Water Commission And For The Purchase And Sale Of Water To The Commission For Commission Use And To Commission Wholesale Water Customers" (the "IGA"), to provide for the governance and operation of the MGNWC and to create the Board of Commissioners of the Morton Grove-Niles Water Commission ("MGNWC Board") to govern the MGNWC; and

WHEREAS, pursuant to MGNWC Purchasing Manuel Chapter 2, Section G Waiver of Competitive Bidding states that the Water Commission, by a two-thirds vote of all the Commissioners then holding office, may waive the bidding procedures and enter into a contract or agreement. Requests for bid waivers shall be made only when goods or services are proprietary (i.e. sole source), where standardization is necessary or desirable, in emergencies as defined in this manual, or when it is in the best interest of the Water Commission to do so. In any instance, a statement justifying the need for a bid waiver shall be included in the department's recommendation; and

WHEREAS, to meet seasonal requirements for establishing a lawn this fall and to match site preparation. It is recommended a landscape services provider be retained; and

WHEREAS, the Superintendent solicited quotes for said work in order to reduce marked up costs by the current contractor conducting work on the site; and

WHEREAS, the MGNWC Board desires to retain KD Staples and Sons Landscaping and Excavating of Lake Zurich ("*Staples*"), Illinois to provide landscaping services ("*Services*") for the East of the Booster Station located at 2551 Church Street, Evanston; and

WHEREAS, the MGNWC Board agrees to Waive the Competitive Bidding as allowed by MGNWC Purchasing Manuel Chapter 2, Section G; and

WHEREAS, the MGNWC Board agrees to retain Staples to perform the Services and to pay the fees not to exceed \$45,000 to Staples in accordance with the terms of the Agreement; and

WHEREAS, Staples has agreed to perform the Services in exchange for payment of the fees in accordance with the terms of the Agreement; and

WHEREAS, the Board of Commissioners of the Morton Grove-Niles Water Commission have the authority to enter into the Agreement pursuant to Article VII, Section 10 of the 1970 Constitution of the State of Illinois, the Illinois Intergovernmental Cooperation Act (5 ILCS 220/1, *et seq.*) and the Illinois Municipal Code (65 ILCS 5/1, *et seq.*, including 65 ILCS 5/11-135-1, *et seq.*), and find that entering into the Agreement is in the best interests of MGNWC, the Village of Morton Grove and the Village of Niles.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE MORTON GROVE-NILES WATER COMMISSION, COOK COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: Each Whereas paragraph above is incorporated by reference into this Section 1 and made a part hereof as material and operative provisions of this Resolution.

SECTION 2: The Board of Commissioners of the Morton Grove-Niles Water Commission ("MGNWC Board") authorize the bid wavier and the attached form of an "Agreement For Landscape Services (Morton Grove-Niles Water Commission And KD Staples and Sons Landscaping and Excavating)" (the "Agreement") for the purposes set forth in the Agreement, attached hereto as **Exhibit "A"**. The MGNWC Board authorize and direct the Chair, or his/her designee, and the Secretary to execute the final version of the Agreement, which may contain certain non-substantive and non-financial modifications that are approved by the MGNWC Board Attorney, and to execute and deliver all other instruments and documents and pay all costs that are necessary to fulfill MGNWC'S obligations under the Agreement.

SECTION 3: This Resolution shall be in full force and effect from and after its adoption and approval as provided by law.
